(4) <u>NOTE :-</u>

- (A) All the eligibility championship mentioned above in para 3 (A) should be conducted under the aegis of recognized International/National/State sports federation and also recognized by Railway Sports Promotion Board. Those Sports Federation which are not recognized or derecognized even after this notification, the certificate issued by them will not be considered for recruitment.
- (B) The sportspersons fulfilling the minimum sports norms for recruitment in higher grades shall be eligible for recruitment in lower grades also. However, such sportsperson will be eligible for promotion/re-appointment in higher grades only on the basis of his sports achievements acquired after joining Railways.
- (C) In Athletics, medal winning performance in National Inter State Senior Athletics Championship may also be considered for recruitment against the posts having Pay Level 2 (As per 6th CPC Grade Pay ₹1900 in Pay Band Rs. 5200-20200) and below. In Athletics, Gold Medal winner in Open National Championship (Senior), Inter State Athletics Championships (Senior) and Asian Championships (Senior) may be considered for recruitment in Pay Level 4/5 (As per 6th CPC Grade Pay ₹2400/2800 in Pay Band Rs. 5200-20200) and below.

- (E) In Boxing discipline, the achievements of players in "Youth" category on or after 25.09.2016 in International Championships will be considered in place of "Junior" category.
- (F) In Cricket (Men) following achievements may also be considered for recruitment in Pay Level 1 (As per 6th CPC Grade Pay ₹1800 in Pay Band ₹ 5200-20200) :
 - **a.** Representation in Main Indian Seniors Team (Men) in 2 Test Matches/Limited Overs One Day International Matches/Twenty-20 Matches.
 - **b.** Representation of India A and India U-19 Team in 2 Test Matches or in 2 Limited Overs One Day International Matches or in 2 Twenty-20 Overs Matches.
 - c. (i) Quarter finalist in Senior/U-25/U-19 All India Inter State Elite Group Championship and All India Inter State Championships or
 - (ii) Participation in Senior/U-25/U-19 All India Senior Inter-zonal Championship.
- (G) In Rifle Shooting, for recognized domestic championships, only individual performance only in "National Championships" will be considered for the purpose of recruitment. "Civilian Championship" is not a recognized category for the said purpose. All India G.V. Mavlankar Shooting Championship is also not a recognized championship for this purpose.

(K) All the recruitments against Open Advertisement Quota shall be at the minimum pay of the Level/scale of pay.

(5) Period of reckoning sports achievements :-

Only those Sportspersons who have acquired the sports achievements - eligibility norms in the championship on or after 01/04/2021 and are active will be eligible to apply for appointment against Sports Quota. For validity of sports achievement, concluding day of the championship/event shall be taken into account.

(6) <u>Age Limit</u> :-

Minimum 18 years and maximum 25 years as on **01.01.2024** i.e must have been born not earlier than **02.01.1999** and not later than **01.01.2006**. No age relaxation (upper age limit or lower age limit) shall be permissible.

<u>Note :-10th/Matriculation Certificate/Equivalent Educational Certificate/Educational</u> Certificate mentioning date of birth are mandatory for D.O.B otherwise application will be rejected)

(7) Examination Fee :-

7.1 <u>Fee Payble :-</u>

(i) For All Candidates except those mentioned in sub- Para (ii) below	₹500/- (Rupees Five Hundred Only) with a provision for refunding of ₹ 400/- (Rupees Four Hundred) to those candidates who actually appear in the trial.
(ii) For candidates belonging to SC/ST/Women/Minorities* & Economically Backward Classes**	₹250/- (Rupees Two Hundred Fifty Only) with a provision for refunding the same to those candidates who actually appear in the trial.

- * Minorities meaning Muslims, Christians, Sikhs, Buddhists, Jains and Zorastrians (Parsis). For claiming waiver of examination fee, Minorities candidates should submit 'self declaration' as mentioned in Annexure-III, At the time of Trial/Document Verification, such candidate claiming waiver of examination fee will be required to furnish 'minority community declaration' affidavit on nonjudicial stamp paper that he/she belongs to any of the above minority communities. If 'self declaration' as mentioned in Annexure-III not uploaded with online application or the affidavit is not produced during Trial/Document Verification, their candidature will be rejected.
- ** Economically Backward Class (EBC) means those whose annual family income is less than Rs. 50,000/-. They have to submit income certificate at the time of applying in the prescribed format as given in Annexure-IV on the letter head of the competent issuing authority.
- **7.2** While applying the candidates claiming fee exemption/refund must upload necessary certificates i.e. SC/ST/Minorities/EBC in prescribed format issued by competent authority.
- **7.3** After ensuring the correctness of the particulars in the application form, candidates are required to pay fees through the payment gateway on RRC-NWR, Jaipur website which has been integrated with the online application. Online fee payment through Net Banking or Debit/Credit Card will be available up to closing date i.e. 15.10.2023 till 23.59 Hrs. No change/edit will be allowed thereafter.
- **7.4** The payment can be made by using Debit Card/Credit Card/Net Banking/UPI etc. By providing information as per the instructions on the computer screen. Transaction charges levied by the Bank for online payment, if any, will be borne by the candidates.
- **7.5** On successful completion of the transaction e-receipt with the date entered by the candidate will be generated which should be saved/printed and retained by the candidate. The same should be produced on demand at the time of Trial/Document Verification.
- **7.6** In case after completing the Registration process, the online transaction is not successfully completed, please make the online payment again. Duplication in payment, if any will be refunded after verifying the same.
- **7.7** Candidates should provide the correct details of beneficiary Bank Account in which they would like to receive the refund viz. Beneficiary name, Bank name, Account number and IFSC Code while filling up the application form to facilitate refund of fees to the eligible candidates as per Para 7.1above after deducting bank charges.
- **7.8** Fee in respect of candidates who are found ineligible shall not be refunded.
- **7.9** Refunds as per para 7.1 above will be made after deducting bank charges only to those candidates who are found eligible as per notification and actually appear in the Trial.

(8) <u>SELECTION PROCEDURE</u> :-

- i. Selection will be based upon Document Verification, performance in Sports Trials and assessment of sports achievement & educational qualification etc. Selection will be conducted by North Western Railway, Headquarter, Jaipur for vacancies of Head Quarter Quota and by respective Division/Workshop for vacancies of Divisions/Workshop Quota.
- **ii.** After scrutiny of applications by Scrutiny Committee short-listed eligible candidates will be called for Document Verification & Trial of sports performance. Candidates who will found suitable in Document Verification by Document Verification Committee, Trials of those candidates will be conducted by Trial Committee. Trial Committee conduct trial to assess their sports performance and suitability for Railway/Unit team as well as Indian Railways team. Trial Committee shall give its recommendation in terms of either FIT or NOT FIT, for consideration for next stage, by giving marks as per the criteria given below :-

- **iii.** After Trial only the FIT Candidates in trial shall be considered for the next stage i.e. assessment of sports achievement & educational qualification by the Recruitment Committee.
- **iv.** Recruitment Committee shall award the marks (out of 60 marks) only to the FIT candidates for their sports achievements, educational qualifications etc. Candidates declared 'NOT FIT' will not be assessed further by the Recruitment Committee.
- **v.** Assessment of sports achievement & educational qualification of the FIT candidates shall invariably be held on the same day, just after trials or at the most, next day of the trials.
- vi. Recruitment Committee is to add the marks given by the Trial Committee to the FIT candidates (i.e., out of 40 marks), in order to make the final merit list (out of 100 marks.)
